Risk of fire or explosion. The Lithium batteries described in this Safety Data Sheet are sealed units which are not hazardous when used according to the recommendations of the manufacturer.

Under normal conditions of use, the electrode materials and liquid electrolyte they contain are not exposed to the outside, provided the battery integrity is maintained and seals remain intact. Exposure may occur as a result of external environmental conditions or in cases of abuse (mechanical, thermal, electrical) which lead to the activation of safety pressure relief valve(s) and/or cause a rupture of the battery container. Electrolyte leakage, electrode materials reaction with moisture/water or battery vent/explosion/fire may follow, depending upon the circumstances.

Dry agent. Do NOT use water. Prevent contamination of drains and waterways.

5.2 Special hazards arising from the substance or mixture

Contents react with water. May explode if exposed to high temperatures due to pressure build up in battery casing. Lithium may burn in a fire situation and may be ejected from the battery. Damaged cells may evolve toxic and flammable vapours. Exposure to fire or temperature above 130°C may cause explosion.

5.3 Advice for firefighters

Evacuate area and contact emergency services. Toxic gases may be evolved in a fire situation. Remain upwind and notify those downwind of hazard. Wear full protective equipment including Self Contained Breathing Apparatus (SCBA) when combating fire. Use waterfog to cool intact containers and nearby storage areas.
